Acknowledgement of Arbitration

The undersigned understands that this Agreement contains an agreement to arbitrate. After signing this document, each party understands that it will not be able to bring a lawsuit concerning any dispute that may arise that is covered by the arbitration agreement unless it involves a question of constitutional or civil rights. Instead, each party agrees to submit any such dispute to an impartial arbitrator.

Services

The Client, pursuant to the Proposal referenced above or a subsequently mutually agreed to written proposal signed by the parties hereto, hereby engages Bloomin' Wild to provide materials (to include without limitation the arrangement of flowers) to the Client in consideration for the compensation as set forth therein (the "Services").

The final table count is required thirty (30) days prior to the event date. In the event that you have fewer tables than outlined in the invoice, these flowers will be distributed throughout other arrangements in your wedding decor.

If Breakdown Services have been contracted, Bloomin' Wild will return to pick up any rental items, dismantle installations, and remove any items listed in the Proposal that remain at the end of the event. The Client is responsible for the removal of all flowers and non-rented containers if Breakdown Services are not previously arranged.

Additional Work and Changes

Requests for changes to the Proposal may be proposed by either party up to thirty-five (35) days before the event date but shall not be effective without the written consent of both parties. Prior to acceptance of any change requests, the parties shall cooperate to equitably determine the impact on pricing, time commitments, scheduling and deadlines, and other project factors and reflect these changes in an updated proposal.
